### Company Policies

1. Policies to become a Company of "Boys' & Girls Christian Brigade of Canada (Hereby will be known as "BGCBC")":
  - a. Company must be a Non-Profit Organization.
  - b. Must submit the BGCBC company registration form.
  - c. Must be admitted as company by BGCBC headquarter.
2. The Right Policies of the company:
  - a. To purchase badges, uniform & other accessories from BGCBC by submitting the purchase form of BGCBC & to provide the name list of the person getting the items.
  - b. To use the BGCBC standard planning program to run the badges & activities program.
  - c. To receive a company number & name which are issued by BGCBC.
  - d. To use the BGCBC logo at different promotion items providing that approval is given by BGCBC after samples are provided for checking process.
3. The Obligations Policies of the company:
  - a. To pay the company fee within the 14 days after the first admitting & annually afterwards.
  - b. To follow the code of Conducts of BGCBC.
  - c. To forward the personal information of the Brigades & the Officers annually to BGCBC for database filing
  - d. To provide the annual budget and financial statement annually to BGCBC.
  - e. To provide Annual Program Form to BGCBC for review & record.
  - f. To keep all the personal information of all Bridges & Officers as strict & confidential for Company internal usage & BGCBC database filing.
  - g. To inform BGCBC any outdoor activities by a "Outdoor Activity Notice Form" for record & it should be provided a month before the activity.
4. The Term Policies of the company:
  - a. It will be a two-years term & is subjected to renew by BGCBC broad of Directors every two years.
5. The annual company fee:
  - a. Currently the company fee is 15% of CAD\$160/Brigader . Fee is subjected to change by notice.
6. Company Termination Policies:
  - a. Company withdraws with a written notice to BGCBC.
  - b. Company term expires.
  - c. BGCBC can terminate company's term by broad of Directors anytime if company fails the code of conducts or is dissolved or is damaging the reputation of BGCBC.
  - d. BGCBC is liquidated and dissolved under the Act.

### **Code of Conduct**

*This Code of Conduct is an integral part of involvement with The Boys' and Girls' Christian Brigade Canada (thereafter BGCBC). The Code of Conduct requires all members, volunteers, employees, and brigades, parents and guardians of brigades to:*

1. Refrain from words, actions and behaviour – in any medium -- that demonstrate disrespect for other members, volunteers, employees, brigades, or the family members of such individuals.
2. Uphold the BGCBC reputation and integrity by ensuring that their conduct, whether in person, online, or otherwise, brings honour and dignity to BGCBC.
3. Be vigilant in ensuring an environment that is safe and protects brigades and adult members, volunteers and employees from emotional, physical, verbal and sexual abuse.
4. Respect other members', volunteers', employees' and brigades' rights to privacy and the confidentiality of their personal information.
5. Act with honesty and integrity when dealing with property, monies and any other assets belonging to BGCBC.
6. Respect and abide by the laws of Canada and of the relevant Province or Territory.
7. Treat members, volunteers, employees, brigades and brigades' families fairly, knowing that BGCBC does not tolerate unlawful discrimination on the basis of race, national or ethnic origin, citizenship, colour, religion, sex, age, mental or physical ability, political beliefs, socio-economic status, health-related status, sexual orientation, marital status, or any other grounds enumerated in the human rights legislation of the jurisdiction in which the individuals involved are located.
